KEYNOTE SPEAKER



DOAN WINKEL

Dr. Doan Winkel is an entrepreneur and an educator, currently leading the entrepreneurship program at John Carroll University. Doan is leveraging AI to revolutionize the teacher and student roles in entrepreneurship education. He is currently exploring how this technology can create stronger human connections between teacher and student and how it enables students to quickly experience the entire startup process. Additionally, his team infused AI into the content delivery, peer interaction, and assessment component of the Experiential Entrepreneurship Curriculum, an award-winning entrepreneurship curriculum he co-founded that is currently used at over 200 colleges and universities. Doan served on the Board of Directors of the United States Association for Small Business and Entrepreneurship for nearly a decade, where he was recognized as a Justin G. Longenecker Fellow for lifetime achievement in entrepreneurship education.

**MICHAEL BOND**

Michael is the founder of Spoken, a Marietta-based app startup that develops technology to help people with speech disorders. He's spent over two decades working in design and tech, with multiple startups as well as brands like Harley-Davidson, John Deere, McDonald's, and BMW. 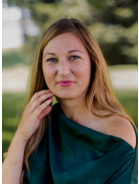

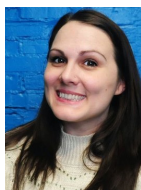


CHRIS SMALLEY, DIRECTOR OF LENDING

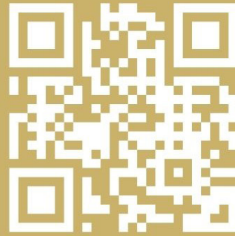

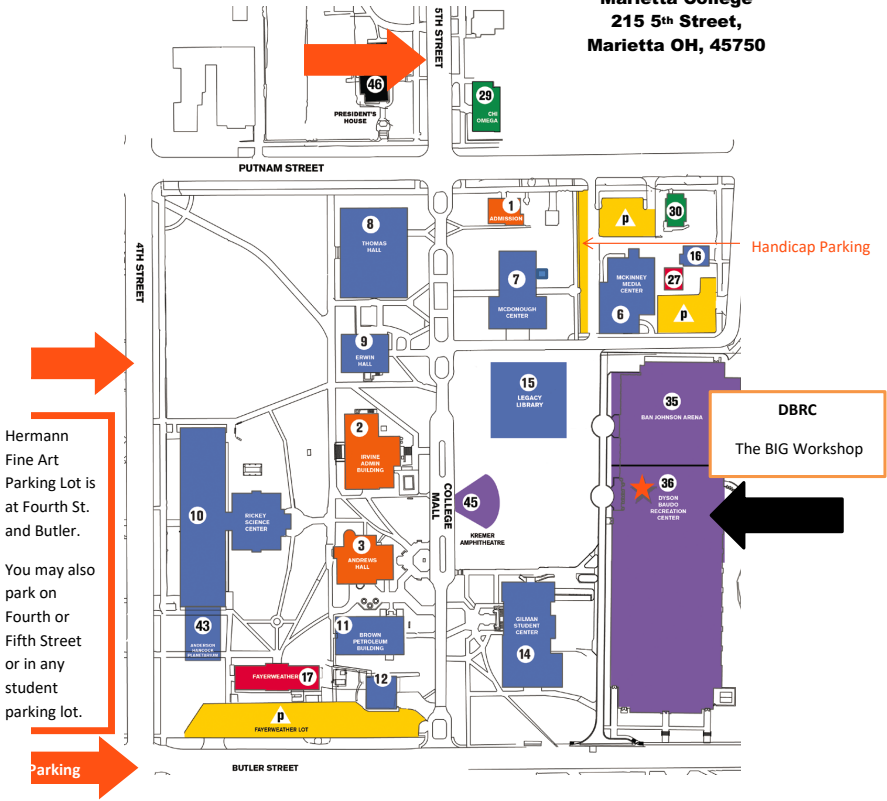
